## **Objectives of IPLSA**

4. To promote and motivate young people or lawyers to foster greater vision for Pro Bono legal services and develop their regional and global network;
5. To promote the awareness of wider application and requirement for legal services in different trades and professions;
6. To improve and enhance humanity; and
7. To engage in any other things incidental and conducive to the above objectives.

## **Personal Information Collection Statement (PICS)**

IPLSA will collect the personal data from various sources of data subject (member). We respect personal data and are committed to implementing and complying with the data protection principles and the relevant provisions of the Personal Data (Privacy) Ordinance.

### 1 Purposes of collecting and keeping personal data

- a. Processing volunteer or staff recruitment and employment related procedures;
- b. Processing administration, such as issue of membership card etc.;
- c. Providing communications, fundraising, and educational materials related to the work of IPLSA such as brochures, newsletters, periodicals etc.;
- d. Organizing fundraising events or educational activities;
- e. Preparing statistics or carrying out any research;
- f. Complying with any statutory requirements or laws that bind IPLSA;
- g. Any other purposes directly or indirectly related to the social services and operation functions of IPLSA.

### 2 Consequence of not providing data

### 3 Transfer of personal data

- b. Any co-organizers, agents or other third parties involved with IPLSA in organizing education or legal related activities;
- c. Any agents, contractors, banks, or other third parties who provide administrative, telecommunication, computer, and other related services in connection with the education, social services and operation functions of IPLSA;
- d. Any statutory, governmental or regulatory bodies or institutions for compliance of any statutory requirements or laws that bind IPLSA.

## 收集個人資料聲明
